With most regret, this is to inform you that till now you have not completed the work and Progress of the PMGSY Package as cited above remains at 47%.

This has badly hampered the social prospects of the Government.

Under these circumstances, Clause No. 52 of SBD is now being invoked and the Contract Agreement made with you is being terminated on grounds of non-completion of the work within allowed time (last time extension period ended on 30.09.2019), with effect from 5th February, 2020.

Further penal measures will be initiated as per relevant Clauses of SBD. The final measurement of the work will be done at 10:30 A.M. on 17.02.2020.

This is extremely urgent.
