- 2) The applicant must submit the duly filled application form along with:
 - o Two (2) recent passport size photographs (to be affixed in the specified place of the application form).

Post Auction Terms & Condition

- 1) Before the bidding starts on the day of the auction, each bidder must deposit the full amount of the Security Deposit (refundable amount) in cash to the designated officer in charge.
- 2) The entire bid amountmust be deposited in the Nadia Zilla Parishad Office within three (3) calendar days from the date of auction through a demand draft in favor of F.C.&C.A.O., Nadia Zilla Parishad or in cash.
- 3) The allotted owner must execute an agreement with the Secretary, Nadia Zilla Parishad within 15 days from the date of auction on a non-judicial stamp paper worth Rs. 20/-, purchased at the owner's expensesas per prescribed terms and conditions.
- 4) After executing theagreement, two months' rentin advance along with any non-refundable advance (where applicable) must be depositedbefore the shop key is handed over.
- 5) Monthly rent must be deposited at the concerned section of Nadia Zilla Parishad by the 7th of each month. If rent remains unpaid for three consecutive months, the Shop/Stall will be forfeited.
- 6) Renewal after one (1) year is subject to satisfactory compliance with the previous terms and a 10% increasein rent.
- 7) The allotted owner must maintain the shop interior at their own expense.
- 8) Business goods must not be stored in verandahs, corridors, common pathways, or outside the shop perimeter. Garbage must be deposited of properly.
- 9) Separate electrical connection must be obtained at the owner's expense from WBSEDCL, and the owner must bear monthly electricity charges.
- 10) No structural alteration are allowed without prior written permission.
- 11) The shop cannot be transferred or rented out to any third party.
- 12) The ownermust obtain necessary Government licensesat his own cost to operate the business.
- 13) Violation of terms, illegal or anti-social activities will result inforfeiture of the shop/stall,
- Periodic external maintenancewill be conducted by Nadia Zilla Parishad.
- 15) The roof is not included in the auction and Nadia Zilla Parishad reserves the right to vertical extension.
- 16) In case of death or permanent disability of the allotted owner within one year, only the spouse/dependent child may be allowed to continue business through fresh agreement, otherwisethe shop will be reclaimed by Nadia Zilla Parishad.
