- The participant of auction shall have at least 2 boats in favour of his name and shall upload the same.
- No CONDITIONAL/INCOMPLETE auction will be accepted under any circumstances.
- 5. Before issuance of the Lease Order, the Auction inviting authority may verify the documents of the highest bidder if found necessary. After verification, if it is found that such documents submitted by the highest bidder is either manufactured or false in that case, Lease Order will not be issued in favour of the highest bidder under any circumstances and auction will be treated as cancelled, as well as the Earnest Money should be forfeited in favour of the Nadia Zilla Parishad.

- 15. The lease amount of each year should be deposited in advance on installment basis. If the yearly lease value exceeds Rs. 1.00 Crore (one crore), the yearly lease value may be deposited at two installments before the staring of year and completion of six months of that particular year.
