Auction Elapse time is maximum 15(fifteen) minutes and Auction Bid auto extensions is also 15(fifteen) minutes. The e-auction shall be ascending forward online electric auction. Minimum incremental value is **Rs. 10,600/-** (Ten thousand Six hundred)only and maximum is 10% of base rate i.e **Rs. 52,940/-** (Fifty-two thousand Nine hundred Forty) only. The earnest money of unsuccessful bidders will be refunded to their respective bank accounts.

4. Before issuance of the Lease Order, the Auction inviting authority may verify the documents of the highest bidder if found necessary. After verification, if it is found that such documents submitted by the highest bidder is either manufactured or false in that case, Lease Order will not be issued in favour of the highest bidder under any circumstances and auction will be treated as cancelled, as well as the Earnest Money should be forfeited in favour of the Nadia Zilla Parishad.
