35. Bid Opening

The received bids will be opened (Except those received late) in the presence of the bidder's representatives who choose to attend at the specified time, date & place. In the event of the specified date for the submission of bids being declared a holiday the bid will be opened at the appointed & location on the next working day.

- The envelope containing the technical bid shall be opened first.
- * In all other cases, the amount of Earnest Money, forms and validity shall be announced. Thereafter the bidders names and such other details as may be considered appropriate will be announced at the opening.
- *. Evaluation of technical bids with respect to qualification information other information in part-I of the bid shall be taken up and completed preferably within the prescribed period and list will be drawn up of the responsive bids whose financial bids are eligible for consideration.

- 36. Compensation for delay in execution of work and Additional Terms and Conditions vide Clause No-111 under Chapter No- VII of West Bengal Panchayat (Zilla Parishad and Panchayat Samity) Finance Rules:
 - (1) The time limit for carrying out the work as specified in the tender papers and the agreement entered into thereon, shall be observed by the contractor and shall be calculated from the date on which the order to commence the work is communicated to the contractor. He shall ensure that the work proceeds throughout the stipulated period of the contract with all due diligence for maintaining the specified schedule of time at every stage of the work.
 - (2) The contractor entrusted with a work shall be liable to pay to the Panchayat body as compensation an amount not exceeding one per cent of the tendered value of work remaining unexecuted for each day of delay and without any prejudice to the generality of this provision, he shall be liable to make such payment on the tendered value of:
 - (i) the entire work when he fails to commence the work on or after the day of commencement of the work as specified in the work order or the agreement executed
 - (ii) any distinct segment of the work when he fails to complete the work of that segment within one month from the date specified for its completion,

- (iii) Uncompleted part of the work if he fails to complete as per the work programme. Provided that compensation not exceeding one per cent on any occasion as referred to in sub-rule (2) may be determined by the Sthayee Samiti in administrative control of the work (hereinafter referred to in this Chapter as Samiti) after giving an opportunity of hearing to the contractor.
- (3) Any contractor aggrieved by the decision of the Samiti referred to in sub-rule (2) may prefer an appeal to the Artha Sthayee Samiti through the Executive Officer against the decision within seven days from the date on which such decision is communicated to him; subject to the provisions in sub-rule (4), the decision of the Artha Sthayee Samiti shall be final.
 - (4) Any contractor aggrieved by the decision of the Artha Sthayee Samiti referred to in sub-rule (3) may submit a review petition to the Zilla Parishad or the Panchayat Samiti as the case may be, through the Executive Officer concerned.
 - (5) On the whole an Affidavit on Non-judicial Stamp of Rs. 10/- (Rupees Ten) to be executed by the Agency in the following terms & conditions on the eve of Stamp Agreement.

Terms:

In partial modification of clause no. 7(Seven) of works agreement of Nadia Zilla Parishad, the following changes have been made with immediate effect.
